Would you like to find out about contracts awarded and their results? You can use the "Public Purchasing" data service for this purpose.

Basic information

You can obtain information about awarded contracts and their results to the extent provided for by law.

In certain cases, public contracting authorities are obliged to comply with information obligations after the award of a contract and to publish certain information on an awarded contract without restriction.

The following information may be subject to the information obligation: Information on the contracting authority, the subject matter of the contract, the award procedure carried out, the type and scope of the service or the place of performance, and the name of the contracted company.

You can view the information on the awarded contract in Internet portals and official publication gazettes.

You can use the Public Purchasing data service to view all information on awarded contracts.

Requirements

- None
- Optional: For the Public Purchasing data service - ELSTER company account for the use of convenience functions such as saving search filters or forwarding found notices.

Procedure

You can find out about awarded contracts and their results.

- The central place to publish information on awarded contracts and their results is the Public Purchasing data service.
- Call up the data service.
- You can use the data service without authentication. Voluntary authentication via ELSTER company account allows you to use convenience features such as saving search filters or forwarding found notices.
- In the search window, enter terms that correspond to the construction, supply or service you offer.
- If necessary, use the advanced search to better narrow the displayed results to your requirements.
- After a successful search, a corresponding hit list is displayed with notices that match the searched criteria.
- In the hit list, the corresponding announcement can be selected and the detailed information displayed.
- In the respective detailed information you will find a link to the awarding platform of the tendering body.
